### 2. Declaration: European Regulation (EC) No 1907/2006 Registration, Evaluation Authorization and Restriction of Chemicals

Teledyne DALSA Digital Imaging (TDDI) produces products that would be considered an Article according to regulation Article 3(3): "an object which during production is given a special shape, surface or design which determines its function to a greater degree than its chemical composition".
