# 1. Declaration: European Directive 2011/65/EC Restriction of Hazardous Substances

This product conforms to the following directive articles:

**Article 4(1):** Product does not contain restricted substances above maximum concentration values tolerated by weight in homogeneous materials, as follows:

- 7(a) Lead in high melting temperature type solders (i.e. lead- based alloys containing 85 % by weight or more lead)
- 7(c)-I Electrical and electronic components containing lead in a glass or ceramic other than dielectric ceramic in capacitors, e.g. piezoelectronic devices, or in a glass or ceramic matrix compound.
- Lead in solders to complete a viable electrical connection between semiconductor die and carrier within integrated circuit flip chip packages.

# 2. Declaration: European Regulation (EC) No 1907/2006 Registration, Evaluation Authorization and Restriction of Chemicals

Teledyne DALSA Digital Imaging (TDDI) produces products that would be considered an Article according to regulation Article 3(3): "an object which during production is given a special shape, surface or design which determines its function to a greater degree than its chemical composition".

As a manufacturer established outside of the European Economic Area (EEA) TDDI does not have direct obligations under the REACH Regulation however we understand that the businesses that import our products into the EEA may have such obligation.

The following requirements may be of relevance to importers;

1. **Article 7(1): Registration** – if substances in articles are intended to be released during normal and reasonable foreseeable conditions of use and are present exceeding one tonne per year they are required to be registered.

TDDI products do not contain any substances intended to be released during normal and reasonably foreseeable use conditions.

2. **Article 7(2): Notification** – when substances of very high concern (SVHC) included on the candidate list for authorization are imported in amounts in excess of 1 tonne per year and present in articles in concentrations > 0.1% wt/wt of the article notification of the European Chemical Agency (ECHA) is required.
