

- Thank you for purchasing this "OPX Series" sensor-controlled coaxial light.
- Before using this product, please read this manual carefully to ensure proper use.
- This product is industrial LED lighting for use as a machine vision light source.
- The warranty period of this product is two years (one year for radiant quantity), starting from the delivery date. CCS will repair or replace the product free of charge if it should fail to function or if the radiant quantity of the product should drop to 50% or less of its initial radiant quantity within the specified warranty period. However, any fault attributable to natural disasters or any other similar disasters or undue alteration or repair will be excluded from the scope of the warranty.

1. Safety Precautions

Safety precautions for ensuring safe operation of this product are displayed as follows with the following symbols. Precautions listed here describe important information about safety. Make sure to follow them accordingly.

4. Precautions for Correct Use

Installation

- Install it to material with good heat dissipation characteristics because this product requires heat dissipation. If the temperature of the housing will exceed 65°C, install the housing to a metal bracket with four times the surface area of the product's light-emitting surface.
- Use mounting screws equal to or shorter than the specified length, and tighten the screws to the specified torque. Tightening torque for product mounting screws : M3 => 60 cN·m, M4 => 150 cN·m
Tightening torque for optional cover mounting screws : M2 => 5 cN·m
- Please note that this product has built-in optical film, so the light-emitting surface should not be subject to outside impacts. Impacts may affect the lens structure of the optical film and carry a risk of causing localized reductions in luminance.

Maintenance

- Do not use thinners, benzene, acetone, alcohol, or kerosene to clean the light-emitting surface. If dust or the like gets on the light-emitting surface, wipe with a soft cloth (such as a lens cleaner). Forcefully wiping may result in scratches appearing.

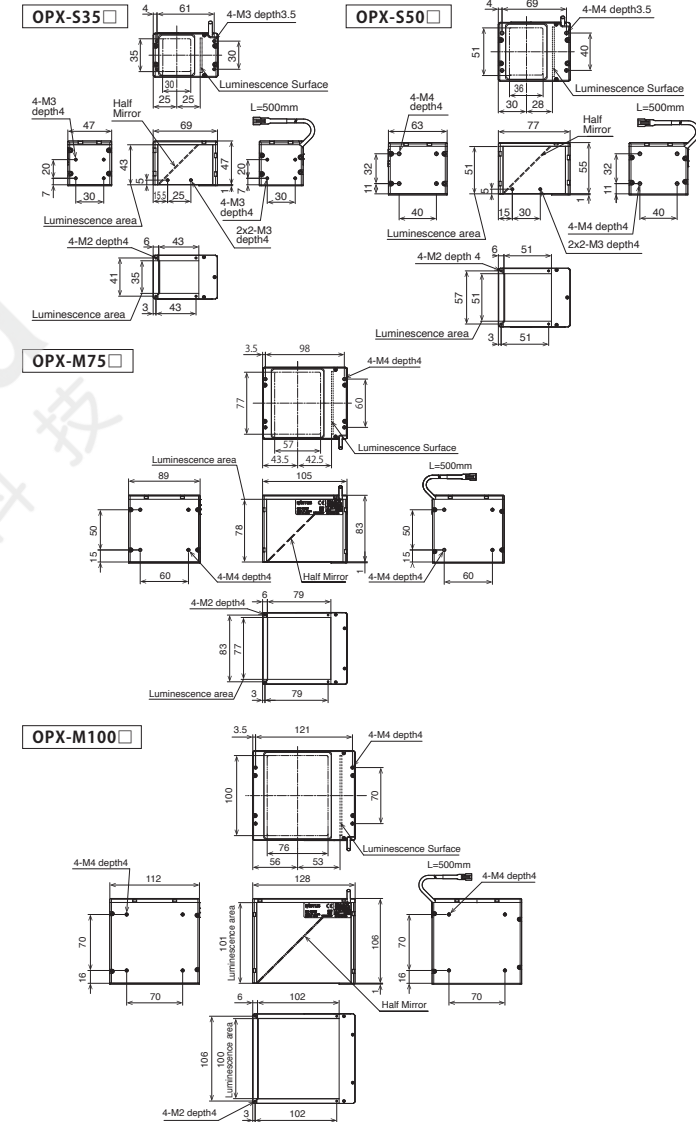
Power

- To use the brightness monitor and feedback function, connect the product to an OPFF Series LED lighting controller (Ver. 109/410 and later).
- *When not using the brightness monitor or feedback function (when used just for illumination), use a 12 VDC power source.

Brightness monitor and feedback function (FALUX sensing)

Set the PWM frequency of the controller (OPFF Series) to 100 kHz (the initial value) or 50 kHz. If the lighting extension cable is longer than 5 meters, it may be difficult for the voltage of the lighting to rise due to the voltage drop resulting from the cable's inductance component and the cable's conductor resistance. This may cause a monitoring error or a feedback error. In such cases, either use a cable that is shorter than five meters, or set the PWM frequency of the OPFF Series to 50 kHz. Feedback function is not available with OPX-M75□ and OPX-M100□. Only monitoring of the brightness of lighting and the internal temperature of the lighting are available for them.
